#### Hello everyone,

In the spirit of Thanksgiving, I just wanted to say thank you to everyone in this community for your continued support of the Monticello Community School District. It is the people in Monticello that make the Monticello Community a special place to live and raise a family. The support for our Elementary School Project was incredible. I am so proud that in a General Election year, almost 61% of the people in Monticello showed their support for this project. I know that this community support is recognized by our staff, and in two years our students will be in an amazing school building that the entire community will be proud of.

It is hard to believe that the weather forecasters are already talking about the first snowfall. I am not sure anyone is quite ready for that yet but it is certainly the right time to remind parents to get connected with the school district. If you do not receive notifications from the Monticello Community School District, and you are the parent of a Monticello Community School District student, please contact the MCSD district office. The notifications keep you in the loop of delays and cancellations as they occur. These notifications can be text or email. Ground zero for weather delays and cancellations has traditionally been in January and February. Those months are quickly approaching so make sure you are getting our notifications. During the winter months we are dialed into the weather forecast. We get out on the roads around 5am and we normally try to make a decision on delays or cancellations by 6am. When possible, we may make an announcement the night before, however, that is hard sometimes because the weather forecast can change quick-ly.

To be better prepared for the upcoming winter season, please spend some time right now making plans on what you will do in the event of a snow delay, early dismissal, or snow day with your children. Make sure you have discussed that plan with your family so when it happens, you are prepared for all circumstances. If you have younger children, please make sure they are bundled up during the winter months. If it is really cold outside make sure they are not outside too long if they are walking to school or even waiting for the bus. If you have middle school students, make sure they are dressing for the colder days. At least once a year, as the colder months get started, I see students from the middle school walking into school with shorts and a t-shirt.

If you have teen drivers in your household, please talk to them about slowing down when it snows, leaving earlier for school so they are not in a rush, and driving defensively around other vehicles. Also, take them out when there is snow on the streets. It is so much better to talk them through driving in snowy conditions, when they can actually drive in snowy conditions. Practice driving between your home and school, that is how they learn to drive in bad weather. Most of our kids took driver's education in the summer, so some winter driving lessons would be very valuable.

Our next School Spirit Newsletter will not come out until January of 2025, so I hope that during the holidays you find some time to rest, relax, and enjoy the special time with your family. If your



kids are younger or older, or if you have a small family or a large one, I hope you make some lasting memories for all. If you are traveling, I wish you safe travels and hope you enjoy every moment with your loved ones.
